## **Contact Information**

The Caravan and Motorhome Club's website has been designed with accessibility in mind, and includes keyboard navigation and Browsealoud texthelp. The Website complies with the W3C level A guidelines.

## **Arrival and Car Parking Facilities**

New arrivals bays are located next to reception. 1 accessible car parking space is located close to reception and the main site entrance, an additional car parking area provides space for 10 vehicles. The site has NO LATE ARRIVAL AREA so all arrivals must be before 8pm. The main site areas are access controlled by a barrier, controls are mounted at a height of 1200mm. From the arrivals area a dropped kerb and pathway provides access to reception.

### Reception

From the main site areas a dropped kerb provides access to pathways around the perimeter of the reception building. Pathways are set to a firm and level gradient. The call bell is mounted at a height of 1500mm. The door to reception achieves an 840mm clear opening width over a level threshold. Internally the reception achieves adequate wheelchair manoeuvring space. The reception counter incorporates a low level position which achieves a 730mm clear knee space. The reception does not incorporate a hearing induction loop system to aid communication with hearing aid users.

### Pitches

The site has a total of 149 pitches, all of which have a hard standing. The site has 18 fully serviced pitches with drainage and water supplies. There are no pitches permanently designated for disabled people. There are 10 hard-standing pitches located on a level section of the site within 40m of the toilet block, including 4 fully serviced pitches. The fully serviced pitches closest to the toilet block are available for reservation on request.

### **Circulation around the Site**

From the main reception building the main access road and pavement to the toilet block slopes upward, the gradient exceeds 1:20 at some points. Remaining access roads are set to a gradient of less than 1:20. Site areas to the north of the toilet block are reasonably level. Most of the access roads around the site are shared by vehicles and pedestrians. There are a small number of pedestrian footpaths and pavements which include a raised pavement linking the toilet block with the reception building.

### Toilet Blocks - 2 blocks on site both with Disabled room, Baby Toddler /Family room & laundry

The toilet blocks are located centrally and have parking spaces for 3 vehicles. The toilet block is accessed via dropped kerbs with an upstand of up to 20mm providing access to perimeter pathways which are set to a firm and level gradient around the perimeter of the building.

The **accessible WC and shower cubicle** door achieves an 840mm clear opening width with a raised chamfered threshold of 20mm. The door is operated by a RADAR key available from reception. The cubicle size is 2950 x 2300mm and achieves adequate wheelchair manoeuvring space to the side of shower and WC positions. The level access shower is left hand transfer, the WC is right hand transfer. The WC, basin and shower have ergonomic lever style controls and are fitted with contrasting grab rails. The cubicle is fitted with an alarm.



**Male and female toilet** doors achieve an 840mm clear opening width over a chamfered raised threshold of 20mm. Ambulant disabled WC and shower cubicles are provided with contrasting grab rails. There is a 100mm step down into the shower cubicles. WCs, basins and showers are fitted with ergonomic lever style controls.

# **Other Facilities**

The **dishwashing area** door achieves an 840mm opening width over a chamfered level threshold of 20mm. Internally the room achieves adequate wheelchair manoeuvring space with a 1700mm clear space in front of sinks. Counter mounted sinks are set at a height of 850mm with a 660mm clear knee space beneath. Sinks are fitted with ergonomic lever style controls.

The **laundry** door achieves an 840mm clear opening width over a chamfered raised threshold of 20mm. Internally the room achieves adequate wheelchair manoeuvring space with a 1700mm clear space maintained in front of the sink and washer dryer positions. The washer and dryer are both front loading and coin operated. Counter mounted sinks are set at a height of 840mm with a clear knee space of 640mm. Sinks are fitted with ergonomic lever style taps.

The **baby and toddler wash room** door achieves an 840mm opening width over a chamfered raised threshold of 20mm. Internally the room achieves adequate wheelchair manoeuvring space. Facilities include a lowered toddler's WC, counter mounted sink, small bath with mixer shower over and baby changing unit mounted at a height of 900mm. The room size is 2300 x 3100mm. The bath and sink are fitted with thumb turn taps.

**Service points** are provided at intervals around the site, providing drinking water, waste water, chemical disposal points, general waste and recycling facilities. These facilities are also provided at the central toilet block along with a motorhome waste point. Service points are mounted on a concrete plinth with a dropped kerb to the access roads. Circulation space does narrow to as little as 700mm at some points.

A **children's playground area** is located to the north of the site accessed from a gravel surfaced pathway and gate with controls at 1200mm above floor level. Children's play equipment is mounted on a safety flooring system. Remaining areas of the playground are grassed.

A **dog walk pathway** is located to the north of the site accessed through a gate with controls at 900mm above floor level. The dog walk pathway does not have a hard surfaced pathway and is grassed.

The **information room** is located opposite reception. Controls to the gated access are set at a height of 900mm. The entrance door achieves an 840mm clear opening width with a raised chamfered threshold of 15mm. A 1200mm clear space is maintained in front of display units and a 1500mm wheelchair manoeuvring space maintained. Information is displayed in the range of 300 – 1600mm above floor level. The majority of information is displayed on counters set at a height of 900mm.

There is no telephone kiosk on site.

The site has a secured compound located adjacent to reception, access controlled by a barrier. Controls are mounted at a height of 1200mm.
